THEREAS by an act made this present parliament, intituled, An act to prevent frauds in the buying and felling of cattle in Smithfield and elsewhere, (amongst other things) it is enacted, That no jebber, falesman, or other broker or factor, who do or shall

1672.] commonly buy or fell cattle for others, be allowed or employed either for buying or felling any fat cattle, other than swine or calves, by or fer any butcher or other person or persons whatsoever, within fourscore. miles of the cities of London and Westminster, upon pain of the forfeiture of the value of the said cattle so bought or sold by him or them as aforesaid, to be paid by the owner of such cattle; (2) and upon further pain, That all and every person and persons taking upon him or them to use or exercise the said employment of a jobber or broker, or of a salesman or factor, for the buying and selling of cattle contrary to the faid act, shall forfeit for every such offence, the value of ail such cattle so bought or sold, or exposed to sale, by him or them as aforesaid; (3) but for that the said clause in the said act contained, is found by experience to be very prejudicial to the fale of the cattle of this realm, and a great inconvenience and discouragement to those that feed the faid cattle in their respective counties, who by reason thereof are forced to make journies up in their own persons to London, or to fend others purposely for that imployment, which commonly taketh up and wasteth all or the greatest part of the profit or gain that they make of their faid cattle; (4) be it therefore enacted by the King's Partofthe act most excellent majesty, and by and with the advice and consent made 22 & 23 of the lords spiritual and temporal, and commons, in this pre- Car. 2. c. 19fent parliament affembled, and by the authority of the same, s.a. repealed.
