This act not to extend to Scotland.

LIV. Provided also, and it is hereby enacted, That nothing in this act contained shall extend to that part of Great Britain called Scotland.

CAP. XXVII.

An all to continue certain laws therein mentioned, for granting, for a limited time, a liberty to carry rice from bis Majesty's provinces of South and North Carolina and Georgia, directly to any part of America to the southward of the said provinces, subject to the like duty as is now paid on the exportation of rice from the said colonies to places in Europe situate to the southward of Cape Finisterre.

Pieamble.

THEREAS it is expedient that the laws herein after mentioned, which have been found useful and beneficial, and which are near expiring, should be continued: may it therefore please your Majesty, that it may be enacted; and be it enacted by the King's most excellent majesty, by and with the advice and consent of the lords spiritual and temporal, and commons, in this present
